This is an overview of reasons that can lead to the rejection of an OKP NFP application.

OKP NFP-SC	employer's statement	Employer's statement is forged	The validity of your employer's statement could not be confirmed
OKP NFP-SC	employer's statement	Employer's statement is expired	The employer's statement is not up-to-date.
OKP NFP-SC	employer's statement	Employer's statement does not include the commitment to retain the candidate's job	Your employer's statement does not include the pledge that you will be able to return to the same or an equivalent position at the end of your fellowship period.
OKP NFP-SC	employer's statement	Employer's statement does not describe a plan of implementation after return to candidate's home country	Your employer's statement does not contain any plans that have been made for putting your newly acquired knowledge and skills to use within your organization.
OKP NFP-SC	employer's statement	Employer's statement does not describe the benefit of the course for the employing organization	Your employer's statement does not contain information on how your organization will benefit from your participation in the course/programme.
OKP NFP-SC	employer's statement	Employers statement is not written by the candidate's current employer	Your employer's statement is not written by the employer you stated as your current employer.

OKP NFP-SC	employer's statement	Employer's statement does not mention why the candidate is the most suitable person to participate in the course	Your employer's statement does not contain information on why your employing organization finds you the most suitable person to participate in the course/programme
OKP NFP-SC	employer's statement	Employer's statement is not provided	You did not provide an employer's statement.
OKP NFP-SC	employer's statement	Employer's statement is not readable	Your employer's statement you attached could not be opened or proved to be unreadable.
OKP NFP-SC	employer's statement	Employer's statement is not signed and stamped	Your employer's statement does not bear an official stamp and signature of your superior.
OKP NFP-SC	employer	Employing organization could not be verified	Your employer's information could not be verified at the time of assessment.
OKP NFP-SC	employer	Employing organization could not be reached by phone after three attempts	Your employer's information could not be verified at the time of assessment.
OKP NFP-SC	employer	Employing organization is not officially registered	Your employer appeared not to be an officially registered organization in your country.
OKP NFP-SC	employer	Employing organization has its own staff development facilities and is therefore considered not eligible for NFP	Your employing organization is considered to have its own staff-development facilities.
OKP NFP-SC	government statement	Government statement is not from competent authority	The government statement you attached is not from the competent authority of your country.
OKP NFP-SC	government statement	Government statement is not provided	Your application does not have a government statement which is mandatory for your country.
OKP NFP-SC	government statement	Government statement is not readable	The government statement you attached could not be opened or proved to be unreadable.
OKP NFP-SC	ID	Identification document is expired	The identification document which you attached is expired.

OKP NFP-SC	ID	Identification document is forged	The validity of your identification document could not be confirmed.
OKP NFP-SC	ID	Identification document is not official	The identification document you attached is not an official document of identification in your country.
OKP NFP-SC	ID	Identification document is not provided	You did not provide an identification document.
OKP NFP-SC	ID	Identification document is not readable	The identification document you attached could not be opened or proved to be unreadable.
OKP NFP-SC	target group	Candidate has been nominated for multiple courses which take place at the same time	You have been nominated for courses/programmes which take place at the same time.
